**Osterley Station Controlled Parking Zone (CPZ) – Zone OS
Review of parking in St Mary's Crescent**

The Osterley Station CPZ was introduced into roads surrounding Osterley Station in early 2010. Since its introduction the CPZ appears to have worked well. However, in response to comments received via your local Councillors from both the Library and Bowls Club, the Councils' Parking Management Team are undertaking a review of the scheme in St Mary's Crescent to seek the views of residents on the effectiveness, or otherwise, of the CPZ and whether improvements could be made.

Suggested issues for consideration

Has the CPZ improved the parking situation? – Do you believe the CPZ has had the desired effect of removing all day parking and increasing parking provision for you as a resident and your visitors? Alternatively, do you consider the parking controls have had a negative impact on parking for you in your road?

Operational times of the CPZ – The current CPZ in St Mary's Crescent is Monday – Friday operates Monday to Friday 9.30am – 5.30pm. We would therefore like to know your views on the current operational days/times, and if you do consider these to be ineffective, what alternatives you would prefer?

It may be that you are currently satisfied with the CPZ and would prefer the scheme to remain unchanged. Perhaps you consider that there are still parking problems in your road at the weekend and that as a result the operational hours should be increased?

Alternatively, as brought to our attention by local Councillors, you may feel the current all-day scheme is too excessive and would like the hours to be reduced as per the Monday to Friday 10am – 12Noon scheme currently in operation in the eastern section of Jersey Road (between Thornbury Road and Ridgeway Road North).

The attached review questionnaire is based on the issues mentioned above. However, whilst we would ask you to comment on these specific points, please let us know of any other suggestions you may have on how the scheme can be improved.

Any other concerns?

It is recognised that there may be other issues that have not as yet been covered. If so, we would ask you to highlight these issues on the attached questionnaire, which will then be considered once all responses have been received. For instance, you may be aware of an opportunity to create more parking spaces, or believe we need to reduce the amount of shared-use (Residents/Pay & Display) bays to allow for more residents bays.

Whether supportive of the current scheme or otherwise I would strongly encourage you to complete the attached questionnaire which would help to provide a clearer indication of residents' views at this time.

I would be grateful if you would return the completed questionnaire by **28 November 2016** at the latest in the pre-paid envelope provided (no stamp required).
