**A. The London Borough of Hounslow (Twickenham Stadium Event Day) (Parking Places) (Amendment No. \*) Order 202\***

1. NOTICE IS HEREBY GIVEN that The London Borough of Hounslow proposes to make the above-mentioned Order under sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Orders would be to in Dawes Avenue, Isleworth, the south side, revoke 4.9 metres of resident permit holders only bay outside No. 35 Dawes Avenue.

The Council of the London Borough of Hounslow, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46, 49 and 124 to the Road Traffic Regulation Act 1984 as amended, and of all other enabling powers hereby make the following Order:

## Citation and Commencement

1. This Order shall come into operation on \*\* \*\*\*\*\* 20\*\* and may be cited as The London Borough of Hounslow (Twickenham Stadium Event Day) (Parking Places) (Amendment No. \*) Order 202\*

## Interpretation

- 2.(1) In this Order the "Order of 2019" means The London Borough of Hounslow (Twickenham Stadium Event Day) (Parking Places) Order 2019.
- (2) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2019 shall have the same meaning as in that Order.
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

## Revocation and/or Designation of Parking Places

2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2019 shall have effect as though:
  - a. the parking place numbered 245 in Schedule 1 to that Order were substituted with the parking place similarly numbered and set out in Schedule 1 to this Order;
  - b. The parking place numbered 245a in Schedule 2 to this Order were added to Schedule 1 to that Order.
